THE SENIOR CENTERS ARE LOCATED IN THE CITIES OF MOUND, MINNETONKA, DELANO, PLYMOUTH, MONTICELLO, AND ST. MICHAEL, MN. THESE CENTERS SERVE SENIORS LIVING IN OVER 40 SUBURBAN AND RURAL MUNICIPALITIES. SENIOR PARTNERS CARE (SPC) WAS ESTABLISHED IN 1973 AS MINNESOTA SENIOR FEDERATION'S FIRST PROGRAM. THE PROGRAM TRANSITIONED TO VOLUNTEERS OF AMERICA IN 2009 WHEN THE MINNESOTA SENIOR FEDERATION DISSOLVED. SENIOR COMMUNITY SERVICES BEGAN ADMINISTERING THE PROGRAM IN APRIL 2012. IN 2012, SENIOR PARTNERS CARE HELPED 1,127 SENIORS ADDRESS A CRITICAL GAP IN HEALTH CARE FOR INDIVIDUALS THAT HAVE MEDICARE, CANNOT AFFORD A MEDICARE SUPPLEMENT, AND ARE NOT ELIGIBLE FOR MEDICAL ASSISTANCE. SPC HAS PARTNERED WITH MOST OF THE MAJOR METROPOLITAN AREA HOSPITALS AND HUNDREDS OF CLINICS AND PROVIDERS STATEWIDE. THESE HEALTHCARE PROVIDERS (SPC PARTNERS) HAVE AGREED TO CONSIDER A WAIVER OF MEDICARE DEDUCTIBLES, COINSURANCE AND CO-PAYMENTS.
