THE SENIOR CENTERS ARE LOCATED IN THE CITIES OF MOUND, MINNETONKA, DELANO, PLYMOUTH, MONTICELLO, AND ST. MICHAEL, MN. THESE CENTERS SERVE SENIORS LIVING IN OVER 40 SUBURBAN AND RURAL MUNICIPALITIES. THERE IS ALSO AN SCS-SUPPORTED COMMUNITY-BASED PROGRAM IN WAYZATA, MN. BY OFFERING SENIOR CENTER PROGRAMMING, SCS HELPED 16,182 SENIORS AVOID ISOLATION, PROTECT THEIR HEALTH AND SAFETY, AND INCREASE THEIR KNOWLEDGE, SKILLS AND ENJOYMENT OF LIFE AS AN OLDER ADULT IN 2011.
